WELCOME AND INTRODUCTIONS

Jimmy Johnson, HBID President, called the meeting to order at 10:05 a.m.

APPROVAL OF THE MINUTES

On a motion by Director Johnson and seconded by Director Raymond the minutes from the January Board meeting were unanimously approved.

The board addressed the advocacy program for the year, including scheduled meetings with Councilmember Hansen (March 7, June 6 and September 5).

Staff gave an update on the general planning and brainstorming session with Handle restaurants. Rooney gave the results of the Doodle Poll (to date). March 28th is the best meeting date (so far). The board to review agenda and meeting format at March meeting.

The board reviewed a sample of the new Handle booklet being developed by Inside Publications. More details in March.

The board discussed the employee parking program. Rooney gave additional background and the board requested more data for next meeting. On a motion by Director Bellarbi-Salah and seconded by Director Raymond, the board unanimously agreed to extend the program for an additional two months (\$1,500).

Rooney presented details on the trash can, pet waste dispensers, bike racks and other planned improvements in the district. Cans will ship around the first of the month. Rooney reported that plans had been shared with city staff and the Councilmember's office.

The board briefly discussed the Handle valet concept. President Johnson and Rooney to meet with operator and report back in March.
